

# REDISTRICTING BRIEFING

**DATE/TIME:** Thursday, February 26, 2015 at 7:00 p.m.

**LOCATION:** Annapolis High School in the Auditorium

On January 7, 2015, the Board of Education of Anne Arundel County voted to move to public hearing the following five redistricting options involving Annapolis-area schools. This briefing is to give the community the opportunity to ask questions and to seek clarification. NO PUBLIC TESTIMONY will be taken. On March 5, 2015, the Board of Education will hold a Public Hearing at which time public testimony will be taken.

## **Tyler Heights Elementary School Options**

- A. Effective in the 2016-2017 school year, shift the Reserve at Quiet Waters neighborhood from Tyler Heights to Georgetown East and the Harbour House neighborhood from Tyler Heights to Eastport. This option was recommended by Superintendent George Arlotto.
- B. Effective in the 2015-2016 school year, shift part of the Reserve at Quiet Waters neighborhood from Tyler Heights to Georgetown East. Effective in the 2016-2017 school year, shift the remaining sections of the Reserve at Quiet Waters neighborhood from Tyler Heights to Georgetown East and the Harbour House neighborhood from Tyler Heights to Eastport.
- C. Effective in the 2015-2016 school year, shift the Reserve at Quiet Waters neighborhood from Tyler Heights to Georgetown East. Effective in the 2016-2017 school year, shift the Harbour House community from Tyler Heights to Eastport and the Bay Ridge Avenue/Tyler Avenue, The Landings, North Green, and Regent Street communities from Tyler Heights to Georgetown East. This option was recommended by the Annapolis Area Redistricting Committee.
- D. Effective in the 2015-2016 school year, shift the Harbor House, Eastport Terrace, and Bay Ridge Avenue/Tyler Avenue North communities from Tyler Heights to Eastport; the Woodside Gardens and Juliana Circle communities from Eastport to Georgetown East; the Ambridge, Timber Creek, and Cedar Ridge communities from Tyler Heights to Georgetown East; the Regent Street community from Tyler Heights to Germantown; and the Severn House, Fairview, Highland, and Parkwood communities from Georgetown East to Eastport. Effective in the 2016-2017 school year, Tyler Heights' prekindergarten program would be transferred to Georgetown East. This proposal was offered by Annapolis resident Jessica Pachler.

## **Admiral Cochrane Drive Area**

- A. Effective in the 2015-2016 school year, shift properties along Admiral Cochrane Drive (including Knights of Columbus property) from the Edgewater Elementary/Central Middle/South River High attendance zones to the Mills-Parole Elementary/Bates Middle/Annapolis High attendance zones.

El 5 de marzo de 2015, la Junta Educativa celebrará una Audiencia Pública en la cual se permitirá testimonio público.

### **Opciones para la Escuela Tyler Heights Elementary**

Cambio efectivo en el curso escolar 2016-2017, traslado del barrio Reserve at Quiet Waters de Tyler Heights a Georgetown East y el barrio Harbour House de Tyler Heights a Eastport. Esta opción fue recomendada por el Superintendente George Arlotto.

B. Cambio efectivo en el curso escolar 2015-2016, traslado de parte del barrio Reserve at Quiet Waters de Tyler Heights a Georgetown East. Cambio efectivo en el curso escolar 2016-2017, traslado del resto de las secciones del barrio Reserve at Quiet Waters de Tyler Heights a Georgetown East y el barrio Harbour House de Tyler Heights a Eastport.

C. Cambio efectivo en el curso escolar 2015-2016, traslado del barrio Reserve at Quiet Waters de Tyler Heights a Georgetown East. Cambio efectivo en el curso escolar 2016-2017, traslado de la comunidad Harbour House de Tyler Heights a Eastport y de las comunidades Bay Ridge Avenue/Tyler Avenue, The Landings, North Green y Regent Street de Tyler Heights a Georgetown East. Esta opción fue recomendada por el comité de reestructuración distrital del área de Annapolis.

D. Cambio efectivo en el curso escolar 2015-2016, traslado de las comunidades Harbor House, Eastport Terrace y Bay Ridge Avenue/Tyler Avenue North de Tyler Heights a Eastport; las comunidades Woodside Gardens y Juliana Circle de Eastport a Georgetown East; las comunidades Ambridge, Timber Creek y Cedar Ridge de Tyler Heights a Georgetown East; la comunidad Regent Street de Tyler Heights a Germantown; y las comunidades Severn House, Fairview, Highland y Parkwood de Georgetown East a Eastport. Cambio efectivo en el curso escolar 2016-2017, el programa de prekindergarten de Tyler Heights sería trasladado a Georgetown East. Esta propuesta fue ofrecida por Jessica Pachler, residente de Annapolis.

### **Área de Admiral Cochrane Drive**

A. Cambio efectivo en el curso escolar 2015-2016, traslado de las propiedades que se encuentran en Admiral Cochrane Drive (incluyendo las propiedades que se encuentran en Knights of Columbus) de las zonas de asistencia Edgewater Elementary/Central Middle/South River High a las zonas de asistencia de Mills-Parole Elementary/Bates Middle/Annapolis High.
