WELLNESS

A. PURPOSE

To provide a comprehensive reference to existing policies and regulations related to the wellness of Anne Arundel County Public Schools (AACPS) students and staff.

B. BACKGROUND

The AACPS Wellness Program is modeled after the Coordinated School Health Program developed by the Centers for Disease Control and Prevention (CDC), which recognizes 10 unique but complementary components, each encompassing and enhancing school instruction, services, and physical and social environments, as well as addressing staff needs. Existing AACPS policies and regulations referenced below relate to, impact, or influence the wellness of AACPS students and staff.

C. PROCEDURES

1. There is an AACPS Wellness Council (Council), under the leadership of the Chief Student and Systemic Supports Officer, that implements and coordinates school health programs in all school facilities and adjunct offices. Representatives from all 10 components of the Coordinated School Health program shall meet regularly at the Council meetings to develop goals, activities, and outcomes to create healthy school environments.
2. In the development of the goals, the Council shall review and consider evidence-based strategies and conduct a comprehensive assessment of school-level wellness in accordance with the federal *Triennial Assessment of the Local School Wellness Policy* requirements at least once every 3 years to demonstrate:
 - a. AACPS compliance;

- b. How the AACPS policy compares to model policies;
 - c. AACPS progress attaining established wellness goals; and
 - d. How the assessment and policy updates will be communicated to the public.
